Preparation: It is extremely important that you read the course materials prior to attending the class. Failure to study the materials before the course commonly leads to failure of the exam

Certification: Those taking the course are eligible to take the Playground Safety Inspectors Exam given immediately after the course. Upon successfully passing the exam, you will be certified through the National Recreation and Park Association as a Certified Playground Safety inspector (CPSI) for a three-year period. Certificates will be awarded and your name will be added to a national roster of CPSI's.

ADA Accommodations: A candidate who has a disability may request a special accommodation. In order to properly accommodate all persons with disabilities it is recommended that all requests come in writing no less than 30 days prior to the course and exam. A request form is available online at www.nrpa.org/CPSI. The course host will work collaboratively with NRPA to ensure all approved accommodations are met.

ESL Accommodations: English as second language (ESL) candidates may request a time extension and/or the use of a strict translation dictionary. Candidates request forms/fees must be submitted to NRPA no less than 30 days prior to the exam. The request form is available online at www.nrpa.org/CPSI. The course host will work collaboratively with NRPA to ensure all approved reasonable accommodations are met.
